Qualification – Riders must complete, **between January 1 and June 21, 2013**, a Super-Randonneur series (200, 300, 400, 600KM brevets) or a 1000km or longer randonnée, or equivalent RUSA Permanent(s). Brevets/Permanents do not have to be ridden in order of increasing distance. ACP or RUSA-sanctioned non-ACP events may be used. All qualification rides must be verifiable. We reserve the right to require verification of qualifying rides.

Substitutions - A longer-distance brevet or permanent may be substituted for a given distance requirement- for example, an ACP 300km brevet or a RUSA 250km brevet for the 200km requirement. RUSA Permanents of equal or greater distances may be substituted for the Super-Randonneur series (200km, 300km, 400km, or 600km) requirement. In limited circumstances, the rider may apply to the organizer for other substitutions. If you have ridden a higher-distance brevet to substitute for a lower distance or other agreed-upon substitution(s), note under "**Subst Dist**". If you are submitting payment prior to qualification, note "**Pending Qualification**" and submit an update when you finish qualifying.

Payment is due with this application. Please pay by a check drawn on a U.S. bank, in \$USD. For riders outside of the U.S., please use a money order or bank draft in \$USD plus \$10. Make check/money orders/bank drafts payable to "Alaska Randonneurs". Thank you for signing up to ride with us!

If paying in foreign currency, calculate your \$USD amount, including the \$10 surcharge, multiply by the exchange rate, and send that sum. For example, payment of the \$425 base fee in United Kingdom Pounds GBP would be $(\$425 + \$10) \times .63 = 274.05$ GBP.

Cancellation - You may cancel by notifying us and receive a full refund if you are on the Waiting List, or a partial refund if you are on the Confirmed list. Preliminary policy for confirmed riders (subject to change), received:

Before March 1: full refund minus \$75

Before April 1: full refund minus \$100

Before May 21: 50% refund.

After May 21: no refund.

ACCIDENT WAIVER AND RELEASE OF LIABILITY

In consideration of being permitted to participate in any way in the **2013 Alaska "Big Wild Ride" Grand Randonnée**, I, for myself, my representatives, assigns, successors, and heirs represent and agree as follows:

I acknowledge that this athletic event or Activity is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of athletes, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to athletics, but are also present for volunteers. I hereby assume all of the risks of participating &/or volunteering in this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently trained for participation in the event and have not been advised otherwise by a qualified medical person. I further acknowledge that the Activity will be conducted over public roads and facilities open to the public during the Activity and upon which the hazards of traveling are to be expected. If at any time I believe conditions to be unsafe I will immediately discontinue further participation in the activity.

I acknowledge that this Accident Waiver and Release of Liability (AWRL) form will be used by the event holders, sponsors and organizers of an event in which I may participate and that it will govern my actions and responsibilities at said events.

In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me or my traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS:

The ALASKA RANDONNEURS, RANDONNEURS USA (RUSA), AUDAX CLUB PARISIEN, and RANDONNEURS MONDIAUX, their directors, officers, employees, volunteers, representatives, and agents, the event holders, event sponsors, event directors, event volunteers are Indemnified and Held Harmless from any and all liabilities or claims made by other individuals or entities as a result of any of my actions during this event.

I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident and or illness during this event.

I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers and or assigns.

This AWRL shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

I hereby certify that I have read this document; and, I understand its content. I understand that I have given up substantial rights by signing this AWRL and have signed it freely and without any inducement or assurance of any nature.

PARENT GUARDIAN WAIVER FOR MINORS (Under 18 years old)
